The Warrenton Historic District (DHR ID 156-0019), located in Fauquier County, Virginia, was originally listed in the National Register of Historic Places and the Virginia Landmarks Register in 1983. The early nomination form identified six areas of significance for the district including Architecture, Commerce, Education, Law, Military, and Politics/Government, for the periods including the 18th, 19th, and 20th centuries. Although the form does not specify the end of the period of significance, it has been generally noted as 1933, or 50 years prior to the completion of the nomination. The purpose of this Additional Documentation is to update the Warrenton Historic District nomination to provide current information about the district's physical condition, to provide further support for the significance of the district, and to extend the end date of the period of significance to 1970.

Additional documentation provided below is extracted from the most up-to-date NRHP nomination form, including Section 5, Classification (with an updated number of contributing and Noncontributing resources); Section 6, Function or Use of Resources; Section 7, Description (including a complete and updated inventory of all resources); Section 8, Statement of Significance; Section 9, Major Bibliographical References (based on new research); Section 11, information regarding authors; and Section 12, new Additional Documentation including an updated Boundary Map and Sketch Maps (showing contributing and noncontributing resources) and photographs of buildings throughout the district. The historic boundaries of the district *have not changed* as a result of this update.

Section 7 of this update includes a complete inventory of previously and newly surveyed resources organized by street name and number. In July 2019, a reconnaissance-level survey of 363 properties in the Warrenton Historic District was conducted, during which surveyors verified the conditions of all previously-documented resources within the district, as well as documented resources not previously surveyed and all substantial-scale secondary resources. The original nomination included an inventory listing 288 contributing buildings, and 35 noncontributing buildings, accompanied by short architectural descriptions of each resource. The 2019 survey and expansion of the period of significance resulted in the identification of 412 contributing resources, including 406 buildings, 2 structures, and 4 objects, as well as 92 noncontributing resources, including 90 buildings and 2 structures. Also included at the end of the inventory are 10 resources that were previously surveyed, but are no longer extant; they are not included in the resource counts in Section 5. The following individually-listed NRHP properties are also within the boundaries of the Warrenton Historic District: **Fauquier County Jail** at 10 Waterloo Street (NRHP 1978; 156-0004/156-0019-0353); **Brentmoor** at 173 Main Street (NRHP 1978; 156-0014/156-0019-0357); and **Paradise** at 158 Winchester Street (NRHP 2014; 156-0019-0320). Section 7 includes a brief overview and description of the district, followed by a complete inventory of the resources surveyed.

Section 8 of this Additional Documentation expands upon the original district's statement of significance. The district's original period of significance was broadly defined to include the 18<sup>th</sup>, 19<sup>th</sup>, and 20<sup>th</sup> centuries, ending in 1933. This update extends the period of significance to 1970, capturing Warrenton's mid-twentieth century growth and development. This update to the Warrenton Historic District also expands upon and provides additional justification for the areas of significance identified in the original nomination, as well as two additional areas. Although Social History is discussed at length in the original nomination, it is not listed as an Area of Significance. Additionally, this update adds Ethnic Heritage: African-American as an Area of Significance. The original nomination form also did not specify under which Criteria the historic district was eligible for the NRHP, which are defined in this update as Criteria A and C. The Statement of Significance for the original nomination goes into detail for several areas of significance, especially related to the town's late-eighteenth and nineteenth-century history. This Additional Documentation will include additional aspects of the district's significance that apply to those areas with a focus on early- to mid-twentieth century, as well as new areas of significance not discussed in the original nomination.

### **Narrative Description**

#### **Summary Paragraph**

Warrenton Historic District encompasses the historic commercial and residential core of the small town, which is centrally located in Fauquier County, Virginia, just 47 miles southwest of Washington, DC. Nestled in the rural, picturesque foothills of the Blue Ridge Mountains, the Town of Warrenton has a long history as the political and commercial center of the county, as well as a hunting and equestrian getaway for Washington, DC politicians and socialites. The town was an important crossroads, where several historic routes intersected including the roads

from Winchester to Fredericksburg, and from Rappahannock and Culpeper to Alexandria. The town maintains an intact commercial and residential historic district with well-preserved examples of high-style and vernacular architecture ranging from the late-eighteenth through the mid-twentieth century. The town's commercial, governmental, and institutional architecture is predominantly located at the core of the district and primarily includes early- to mid-twentieth-century Main Street Commercial style buildings, as well as high-style Georgian, Colonial, and Neo-classical revival style architecture. The most popular style for residential buildings constructed during the early- to mid-twentieth century was Colonial Revival. The district also retains a high number of nineteenth-century residential building constructed in the Federal style. Additionally, the district includes outstanding examples of Italianate, Queen Anne, Folk Victorian, and Craftsman style houses, as well as a few mid-twentieth century Ranch houses. Warrenton Historic District includes 412 contributing and 92 noncontributing resources, and retains a high degree of architectural and historic integrity associated with its period of significance.

**Narrative Description****Setting and Landscape**

The Warrenton Historic District is located in the rural courthouse town of Fauquier County. The commercial core of the district is situated on a plateau. The town's streets are laid in a grid-like pattern and are lined by sidewalks and minimal vegetation and a few small trees. The commercial area also includes several small parks that include more landscaping and vegetation as well as large, mature trees. The residential areas of the district are typically made up of larger lots that have more mature vegetation, including lush lawns and ornate gardens, as well as decorative garden features such as fountains and paved walkways. Just outside the historic district boundaries are areas that the town annexed in the mid- to late- twentieth century, including major traffic routes such as US 17, US 15, US 211, and US 29. Because these major transportation routes and the railroad circled rather than traversed the town, the historic character of Warrenton Historic District remains intact.

**Integrity Analysis**

The Warrenton Historic District retains high integrity as described more fully below, with significantly more contributing resources than noncontributing resources. Located in central Fauquier County in Northern Virginia, Warrenton is surrounded by the still relatively rural landscape of the Blue Ridge foothills, and maintains its integrity of location and setting. A vast majority of the resources in the district retain integrity of design, materials, and workmanship associated with their various styles and construction methods. These contributing resources together help convey Warrenton's historic feeling and association with its areas and period of significance.

## Inventory

The attached inventory is the result of reconnaissance-level survey of 363 properties conducted in July 2019. Surveyors verified the conditions of all previously-documented resources within the district, as well as documented resources not previously surveyed and all significant secondary resources. The original nomination included an inventory listing 288 contributing buildings and 35 noncontributing buildings, accompanied by short architectural descriptions of each resource. The 2019 survey and expansion of the period of significance resulted in the identification of 411 contributing resources, including 406 buildings, 2 structures, and 4 objects, as well as 92 noncontributing resources, including 90 buildings and 2 structures. Also included at the end of the inventory are 10 resources that were previously surveyed, but are no longer extant; they are not included in the resource counts in Section 5. The following individually listed NRHP properties are also within the boundaries of the Warrenton Historic District: **Fauquier County Jail** at 10 Waterloo Street (NRHP 1978; 156-0004/156-0019-0353); **Brentmoor** at 173 Main Street (NRHP 1978; 156-0014/156-0019-0357); and **Paradise** at 158 Winchester Street (NRHP 2014; 156-0019-0320).

Each entry in the attached inventory identifies the primary and secondary (where applicable) resource, the resource type (building, site, structure, or object), number of stories, architectural style, approximate construction date, and contributing or noncontributing status. Resources within the Warrenton Historic District are considered contributing if they were constructed during the district's period of significance (1759-1970), are associated with one or more of the district's areas of significance, and retain integrity to convey their historic associations.

Alterations to contributing resources were evaluated based on the overall impact to the character-defining features of the building. A detailed architectural description and surveyor assessment for each resource has also been prepared in conjunction with this nomination update, and can be accessed via the Virginia Department of Historic Resources architectural survey archives and/or the Virginia Cultural Resources Information System (V-CRIS).

**Statement of Significance Summary Paragraph**

Warrenton Historic District (DHR ID 156-0019), located in Fauquier County, Virginia, was originally listed in the National Register of Historic Places and the Virginia Landmarks Register in 1983. The early nomination form identified six areas of significance for the district including Architecture, Commerce, Education, Law, Military, and Politics/Government, for the periods including the 18th, 19th, and 20th centuries. Although the form does not specify the end of the period of significance, it has been generally noted as 1933, or 50 years prior to the completion of

the nomination. This nomination update provides additional context and justification for several of the original areas of significance; adds two areas of significance, Ethnic Heritage: African American and Social History; and extends the period of significance to include mid-twentieth century resources which are associated with the district's areas of significance.

The Warrenton Historic District is locally significant under Criterion A for **Law and Politics/Government** as the seat of Fauquier County and the location of the Town's municipal offices, and for its association with prominent local, state, and national lawmakers, lawyers, and politicians. The Warrenton Historic District is also locally significant under Criterion A in the areas of **Commerce**, as the historic central business district for the town and the county for more than two centuries; **Education**, for its association with several nineteenth and early twentieth century preparatory schools and early educational institutions for African Americans following the Civil War through the racial integration of public schools in the mid-twentieth century; **Military**, for the district's association with the Civil War; and **Social History**, as the center of cultural institutions, clubs, and sporting events such as horseback riding and hunting. The Warrenton Historic District is locally significant under Criterion A in the area of **Ethnic Heritage: African-American** for its association with the events of Reconstruction through the Civil Rights Movement in Warrenton. The Warrenton Historic District is also locally significant under Criterion C for **Architecture**, as a noteworthy collection of late-eighteenth to mid-twentieth century buildings representative of national stylistic trends, as well as local vernacular traditions. The district's period of significance begins in 1759, when what later became the Town of Warrenton was established as the seat of Fauquier County, and ends in 1970 to include resources associated with the district's significance through the third quarter of the twentieth century in the aforementioned areas of significance.

### **Criterion A: Education**

The Warrenton Historic District is locally significant under Criterion A in the area of Education for its association with the town's early educational institutions beginning in the mid-nineteenth century through the late nineteenth to early twentieth century schools established for African-American children. Although the historic district was once home to a number of properties associated with education, only three such resources remain intact inside the district boundary. These resources, however, are representative of more than a century of educational history in the Town of Warrenton, and the evolution of educational policy at the local, state, and national level. These extant institutions include **Miss Swift's School for Girls located at 109 Main Street (156-0019-0363)**, established in the 1840s in the former town market constructed ca. 1830; the **Fauquier Female Seminary located at 194 Lee Street (156-0019-0190)**, established in 1856; and the **School for African-American children in the Odd Fellows Hall at 23 S. 3<sup>rd</sup> Street (156-0019-0280)**, which operated from ca. 1871 through the 1910s.

Warrenton Historic District and its outlying areas were home to several private educational institutions during the late-nineteenth and early-twentieth centuries. Likely the earliest educational institution in Warrenton was the Warren Academy, established in 1786 and was located on what later became known as Academy Hill. The Warren Academy building was destroyed several times by neglect, natural disaster, and fire, but continued to operate through the Civil War.<sup>1</sup> During the mid-nineteenth century, elite Virginia families and some churches organized private educational institutions and academies throughout the state. In 1856, the Fauquier Female Seminary (later known as the Warrenton Female Seminary and the Fauquier Institute) was established, and opened one year later at 194 Lee Street in Warrenton.<sup>2</sup> Elite white families sent their daughters to the Fauquier Institute to learn various subjects including languages, literature, and music. The Italianate-style building sat on a 10-acre campus near the edge of the town, typical of the larger private institutions established in the county. Although the Fauquier Institute closed its doors as a school for young women in 1925, the building serves as the last remaining resource representative of Warrenton's early boarding school history.

In 1869, the Virginia Legislature established a new state constitution, a requirement by the Federal government following the Civil War. This new constitution provided for the first time a

statewide public education system. Academy Hill, located within the Warrenton Historic District, was prior to 1983 the location of two local public schools. The Warrenton School, constructed ca. 1908, sat at the northeast corner of Academy Road and N. 1<sup>st</sup> Street (now Horner and Academy Hill Road). From 1915 to 1924, the two-story Classical Revival brick building served as the Warrenton High School. In 1924, a new high school was constructed adjacent to the former school, which became the Warrenton Elementary School. As the town continued to grow, it constructed another new high school in 1936, just outside the boundaries of the historic district on Waterloo Street, while the 1924 high school assumed the role of Warrenton Junior High School. Each of Warrenton's Academy Hill public schools were reserved strictly for white students, as Fauquier County schools remained racially segregated until 1969.

*African-American Education, Massive Resistance, and Desegregation of Fauquier County Schools*

Warrenton Historic District is also significant for its connection to the educational efforts of the Bureau of Refugees, Freedmen, and Abandoned Lands, also known as the Freedmen's Bureau. The Freedmen's Bureau, which had a local field office in Warrenton, opened a school for African Americans in Warrenton in February 1866. The school was located near the corner of Lee and 4<sup>th</sup> (now 3<sup>rd</sup>) Streets on land formerly belonging to Abraham Rindsberg, a prominent Jewish merchant and landowner in Warrenton. The Freedmen's Bureau school's first teacher was Miss S. Fannie Wood, from Middleboro, Massachusetts. Wood, who was employed by the New England Freedmen's Aid Society, named the school the Whittier School after the Massachusetts Quaker poet and abolitionist John Greenleaf Whittier.<sup>3</sup> By early 1868, George H. Morse replaced Wood as the Freedmen's School teacher. Morse reported an average of 50 day students, and another 15 night school students.<sup>4</sup> In many ways, the Freedmen's School in Warrenton is representative of the educational activities of the Bureau across Virginia. By 1868, the Freedmen's Bureau operated nearly 270 schools in Virginia, with more than 350 teachers serving approximately 20,000 students. Schools provided lessons in reading, writing, arithmetic, and geography to those without other educational opportunities.<sup>5</sup> The Freedmen's Bureau, however,

received insufficient financial appropriations under the administration of President Andrew Johnson, and by 1870, all Freedmen's Bureau educational operations ceased.<sup>6</sup>

Following the closure of Warrenton's Freedmen's Bureau school, the local chapter of the Grand United Order of Odd Fellows (G.U.O.O.F; further discussed below in Social History) provided accommodations for a school for African-American children in their building at 23 S. 3<sup>rd</sup> Street. Depicted as the "Colored Odd Fellows Hall & School" in the 1886, 1891, 1903, and 1908 Sanborn Fire Insurance Maps, it is likely that the building housed the school from the early 1870s, when the Odd Fellows was established, through the mid-1910s when the county started to construct Rosenwald-funded schools for African-American children.<sup>7</sup>

Beginning in 1917, the Rosenwald Foundation, established by Sears, Roebuck, & Co. President, Julius Rosenwald in partnership with Booker T. Washington of the Tuskegee Institute, began to provide financial assistance for the construction of rural educational facilities for African Americans. In total, eight Rosenwald Schools were constructed in Fauquier County, including the ca. 1918 Warrenton Training Center, the largest in the county. Located on East Shirley Highway, the Warrenton Training Center, later known as the Rosenwald High School, cost \$3,200 to build, which was funded through a combination of sources including \$700 from the local school board, \$800 from the Rosenwald Foundation, \$700 from local white residents, and \$1,000 from the local African-American community.<sup>8</sup> Prior to the construction of Rosenwald High Schools, African-American students seeking secondary education were required to make the long trip to the Manassas Industrial School, a "Regional High School of Northern Virginia," providing residential and day school programs for students over the age of 14.<sup>9</sup> In 1952, the county constructed a new high school for African-American students. W. C. Taylor High School, named for the principal of the Rosenwald High School from 1929-1945, was considered a "model of its kind," and included a gymnasium, auditorium, cafeteria, a vocational and agricultural shop, laboratory equipment, in addition to modern classrooms and an "up to date heating system."<sup>10</sup> The new high school, however, remained racially segregated until 1969.

Two years after the opening of W. C. Taylor High School, the U.S. Supreme struck down segregation laws based on the notion that "separate but equal" facilities were unconstitutional in the landmark case, *Brown v. Board of Education, 1954*. Following an order to integrate public

educational facilities with “all deliberate speed,” the Virginia legislature passed a series of laws over a fifteen-year period that attempted to circumvent the Supreme Court ruling. By the late 1960s, much of Virginia, including Fauquier County was operating under the “Freedom of Choice Plan.” Under this plan, students were given the opportunity to choose the school they wanted to attend. In practice, “Freedom of Choice,” rarely resulted in full integration. From 1963 to 1968, more than a decade after *Brown v. Board of Education*, Fauquier County schools operated under the “Freedom of Choice” plan. Although a few African-American students already attended Fauquier High School, the majority of African-American students attended Taylor High School.<sup>11</sup> Following the Supreme Court decision in *Green v. School Board of New Kent County* in 1968, which deemed “Freedom of Choice” insufficient for integrating public school, Fauquier County School Board was ordered to develop a plan for zone-based school integration by the Fall of 1969.<sup>12</sup> In 1969, all of Fauquier County’s schools fully integrated including those schools inside Warrenton’s historic district, which are no longer extant.

### **Criterion A: Commerce**

The Warrenton Historic District is also locally significant under Criterion A in the area of Commerce as the historic commercial corridor for the town and the county. The original historic district nomination discusses at length the nineteenth century commercial history and significance of the district. This update focuses on the development of the district primarily after the fire of 1909, where the original nomination left off. This update also includes additional information related to African-American businesses within the district from the late nineteenth through the mid-twentieth century.

In 1909, a fire swept through a large area on the western side of Warrenton’s historic commercial area, primarily to the west of Culpeper Street. Approximately 26 buildings burned, while another nine structures were destroyed by dynamite in order to control the fire.<sup>13</sup> By 1915, the town had recovered significantly, introducing a number of new buildings near the public square. Prior to the fire, Warrenton’s commercial corridor was primarily concentrated along Main Street from the Public Square to 4<sup>th</sup> Street (now 3<sup>rd</sup> Street), and along Culpeper and Lee Streets. By 1947, however, the number of commercial buildings or conversions of residential structures to

commercial use extended east along Main Street to 2<sup>nd</sup> Street (now 5<sup>th</sup> Street).<sup>14</sup> Warrenton's commercial district continued to be occupied with traditional goods and service providers; however, Warrenton also welcomed national department store chains such as **S. H. Kress & Co.** in the C. M. Sauer Building located at **36 Main Street (156-0019-0211)** and the **Lerner Bros. Department Store at 11 Main Street (156-0019-0200)**.<sup>15</sup>

The original Warrenton Historic District nomination highlighted the commercial enterprises of the Ullmans, a prominent Jewish family, including the **Ullman Department Stores at 51 and 53 Lee Streets (156-0019-165 and 156-0019-166)**. Although originally established by Adolph Ullman and his father-in-law, Abraham Rindsberg, Ullman's untimely death left his wife Caroline (Carrie) Rindsberg Ullman the matriarch of the family's commercial empire. According to the Fauquier Historical Society, "Under Caroline Ullman's management, the store became the largest in Warrenton, as well as its longest-lived, marking more than one hundred years in business under one family's ownership."<sup>16</sup> Caroline Ullman also diversified the family's commercial enterprises, and in 1897 purchased the **Warren Green Hotel located at 10-22 Hotel Street (156-0019-0355)**. The Warren Green Hotel was a popular destination for visitors and an entertainment venue for tourists and locals alike. Musicians like the legendary Duke Ellington are reported to have played at the hotel, while socialites like Wallis Simpson, later known as the Duchess of Windsor, stayed at the hotel.<sup>17</sup> Simpson, whose intended marriage to British king Edward VIII caused a constitutional crisis leading to Edward's abdication in 1936, lived at the hotel for over a year in 1925 to 1927 while awaiting finalization of her first divorce.<sup>18</sup> The Warren Green Hotel was also a stop for notable politicians and leaders, including President Theodore Roosevelt in 1909. Following Caroline Ullman's death in 1942 at the age of 94, the Ullman family businesses remained under the management of Caroline and Adolph's son, Joseph Ullman until his death in 1953.<sup>19</sup> In 1960, the Warren Green Hotel was purchased by Fauquier County and was renovated to house the county's government offices, where they are still located in 2019.<sup>20</sup> The **Ullman Family Residence located at 157 Culpeper Street (156-0019-0054)** is also within the Warrenton Historic District. The Ullman residence is one of the finest and most unique examples of Second Empire style architecture in the district, featuring a star of David in the Mansard roof. The Ullman family house and business represent the family's significant contributions to the district's commercial history and their individual entrepreneurial success.

Warrenton Historic District is also home to two of the town's prominent financial institutions, the Fauquier National Bank and the People's National Bank. Both banks expanded their operations and building footprints during the district's period of significance. From 1925 to 1971, the building located at **18 Court Street (156-0019-0020)** served as the headquarters for Fauquier National Bank, on the site of an earlier bank building which the financial institution had outgrown. The building, designed by Winchester, Virginia, architect Stuart H. Edmonds, boasts "outstanding architectural merit" and was a symbol of the town's economic success and commercial significance for nearly 50 years.<sup>21</sup> In 1971, the bank expanded again, opening its new location at 10 Court House Square (156-0019-0295; Noncontributing). The former Fauquier National Bank was transferred to the Town of Warrenton, where it has housed its municipal offices since 1973. The Peoples National Bank expanded and remodeled its ca. 1910 bank building at **21 Main Street (156-0019-0204)** in 1956. This 1956 Colonial Revival style expansion is also linked to the economic and commercial prestige of the community. Although the original bank building was altered to accommodate this expansion, the new building and its updated façade have gained significance in their own right under both Criteria A and C. In 1986, the company expanded operations again, constructing a three-story addition to the west of the ca.1956 building.<sup>22</sup>

The Warrenton Historic District is also significant for its association with commercial activities of local African-American entrepreneurs, and as a commercial center for African Americans seeking goods and services from both the town and the surrounding area. From Reconstruction through the Civil Rights Movement of the mid-twentieth century, Jim Crow laws segregated the public and private lives of white and black citizens. This included public spaces as well as private business establishments including restaurants, hotels, beauty salons, etc. As early as the 1870s, the building located at **22 Main Street (156-0019-0205)** served as Madison's Barber Shop. The shop and its bartering tradition were passed down through the Madison Family.<sup>23</sup>

Another Warrenton family, the Walkers, also owned and operated a barber shop in the historic district throughout the twentieth century. George E. Walker first opened his barber shop in 1938, and it too passed down through the generations. Located inside the Odd Fellows building at **23 S. 3<sup>rd</sup> Street (156-0019-0280)**, Walker's Barber Shop was advertised in the Green Book from 1947 to 1954, in addition to the following Warrenton businesses: the Lawson Tourist Home at 227 Alexandria Pike (outside the historic district boundary), Tulip Fowler's Beauty Parlor at 123 N. 3<sup>rd</sup> Street (now **31 N 4<sup>th</sup> Street, 156-0019-0110**, demolished), Finn Beauty Parlor, at 121 N. 5<sup>th</sup> Street, and McLain's Tailor Shop at **205 Culpepper Street (now 51 Culpeper Street, 156-**

**0019-0039**), as well as several Taxi Cab companies.<sup>24</sup> The Green Book, in print from 1936 to 1964, provided African Americans with a guide for traveling during the Jim Crow era, listing businesses that welcomed black customers and visitors without discrimination. Prior to publication of the Green Book, African-Americans learned how to navigate segregation in new places through word of mouth. In the Green Book's 20<sup>th</sup> Anniversary Edition, published in 1956, contributor Novera C. Dashiell described the history and purpose of the traveler's guide, stating:

Our leaders and educators look forward to the day when as a racial group, we will enjoy the rights and privileges guaranteed us, but as of now withheld in certain areas of these United States. With this in mind, the idea was conceived by Victor H. Green, publisher-owner of the unique Negro Motorist Green Book about 1932. The idea crystallized when, not only himself but several friends and acquaintances complained of the difficulties encountered; oftentimes painful embarrassments suffered which ruined a vacation or business trip.<sup>25</sup>

Walker's Barber Shop, however, not only accommodated tourists and locals. Robert L. Walker, the most recent proprietor of the shop, remembered men coming from surrounding towns, some from as far as Manassas and other parts of Northern Virginia because it was the only place for them to get a haircut.<sup>26</sup>

Although not listed in the Green Book, Warrenton Historic District was home to several other African-American-owned businesses including restaurants like Jenkin's Lunchroom on S. Fifth Street and Evelyn and Joe Brown's Hilltop on S. Fifth Street.<sup>27</sup> Mamie Bland operated a hotel for African Americans known as the Black and Gold Inn, where residents and travelers could also dine.<sup>28</sup> Oral tradition states that local musician Chauncy DePew Brown, known to have performed with jazz legend Duke Ellington, often performed for locals and guests of the Black

and Gold.<sup>29</sup> **The Black and Gold, located at 31 S. 2<sup>nd</sup> Street (156-0019-0271),** retains historic and architectural integrity, and is easily identifiable in historic photographs.

Businesses in the Warrenton Historic District remained racially segregated until 1963. At the height of the Civil Rights movement in the early 1960s, businessmen in Warrenton led the charge to desegregate their facilities in an effort to minimize the threat of violence against peaceful protest, as had occurred in other parts of the American South. In early 1963, the Congress of Racial Equality (CORE) was threatening to bus protesters into Warrenton. This threat motivated the Warrenton-Fauquier County Chamber of Commerce, then headed by Maximilian A. Tufts, to extend membership to African-American groups and businesses. The first group to receive and accept the invitation was the American Legion Post 360, “a black veterans post organized in Warrenton in 1959.”<sup>30</sup> The two organizations developed a special committee that met at Airlie, just north of Warrenton, to discuss a strategy for peacefully integrating the town’s restaurants and lunch counters. In June 1963, the committee met with restaurant and motel owners in the **Fauquier National Bank Building located at 18 Court Street (156-0019-0020)** to discuss and develop a plan. After testing the Chamber-Legion plan in several restaurants around town, the Fauquier Democrat announced the success of the plan with the headline, “Warrenton Restaurants, Lunchrooms Desegregate.”<sup>31</sup> Following the desegregation of the town’s dining facilities, it was also reported that several chain stores loosened restrictions on hiring African Americans, and that “the Pitts Fauquier Theater in Warrenton was also desegregated.”<sup>32</sup> The desegregation of Warrenton’s businesses was commended by President John F. Kennedy, who often visited the area and had a home in nearby Middleburg, Virginia. The President described the grassroots initiative as a model for other localities.<sup>33</sup>

### **Criterion A: Social History**

The Warrenton Historic District is also locally significant under Criterion A in the area of Social History. The social history of Warrenton was discussed at length in the original nomination under the section titled “Society and Culture;” however, the nomination did not specifically identify this as an area of significance. The information, rather, was treated as additional

information near the end of Section 8. This update to the nomination identifies Social History as an Area of Significance for the Warrenton Historic District for its association with numerous local hunt and equestrian clubs, as well as fraternal organizations. Since much of the history on Warrenton's hunt clubs and equestrian history were discussed in the original nomination, this update will focus on the town's fraternal organizations.

Warrenton Historic District retains several buildings associated with fraternal groups and societies. In the United States, fraternal organizations gained significant popularity during the nineteenth through the mid-twentieth century. Described by historians Theda Skocpol and Jennifer Lynn Oser, "fraternal associations are self-selecting brotherhoods and sisterhoods that provide mutual aid to members, enact group rituals, and engage in community service."<sup>34</sup> Among the oldest and most well-known of the fraternal orders in the United States is the Order of the Freemasons. The first Masonic Lodge in the United States was founded in Boston in 1733. Freemasonry promoted republican ideals like those that influenced the American Constitution and Bill of Rights such as individual freedom, free enterprise, limited state powers, and self-government.<sup>35</sup> The Warrenton Lodge No. 69 was first chartered by the Grand Lodge of Virginia in 1803. The charter for the local Lodge was reissued as the Mt. Carmel Lodge No. 133 in 1823, 1846, and 1852. Meetings for Mt. Carmel Lodge were held in the two-story, ca. 1830 brick building at **109 Main Street (156-0019-0363)** from 1831 to 1877.<sup>36</sup> In 1876, the three-story Italianate building located at **7-11 Culpeper Street (156-0019-0023)**, was constructed to house the Masonic Lodge, where the organization was active until 1970.<sup>37</sup>

Following the construction of the new Masonic Lodge, the building located at **109 Main Street (156-0019-0363)** became home to another significant American fraternal society, the Independent Order of Odd Fellows (IOOF) in 1877. Originally established in the United States in 1819 in Baltimore under the Manchester Unit of Oddfellows in England, the IOOF split from its English counterpart in 1842. According to historian David Beito, "The IOOF was an American fraternal trendsetter."<sup>38</sup> In addition to providing a "clear schedule of guaranteed benefits" including a regular stipend during periods of unemployment, the IOOF "helped revise the language of American fraternalism," using the term "benefit" and "right" rather than "charity"

and “relief.”<sup>39</sup> By 1877, the IOOF had become one of the most prominent American fraternal organizations, with approximately 465,000 members.

Warrenton Historic District is also significant for its collection of African-American fraternal lodges and halls, which were often parallel organizations formed by and for black residents who were barred from membership in established fraternal organizations like the Freemasons and IOOF. According to Skocpol and Oser, “Prior to the 1970s, only a handful of major U.S. white associations were willing to accept African Americans as members...But the vast majority of U.S. white-led groups had explicit racial exclusion clauses in their constitutions or regularly practiced racial exclusion.”<sup>40</sup> African Americans, therefore, established independent fraternal associations, which were seen as “quintessentially American” and “exemplified their desire to fully participate in this vital aspect of U.S. civic life.”<sup>41</sup> Black fraternal organizations, much like churches, became important cultural, civic, and political institutions that provided community service and educational support, space for community events and businesses in their lodges and halls, and sometimes participated in political activism including the mid-twentieth century civil rights movement.

Warrenton Historic District is associated with at least three African-American fraternal organizations established in the late-nineteenth and early-twentieth centuries. The earliest and most nationally prominent society established in Warrenton was the Grand United Order of Odd Fellows (GUOOF), which occupied the building located at **23 S. 3<sup>rd</sup> Street (156-0019-0280)** beginning in the early 1870s. When the IOOF broke away from the parent organization in England in the early 1840s, it refused to offer a charter for an African-American chapter. Therefore, Peter Ogden sought and received a charter from the Grant United Order in Liverpool in 1843 for the GUOOF. The organization, which provided “social insurance benefits; built social institutions as well as halls that served as meeting places for many black groups; engaged in impressive parades and ritual displays; and attracted leading men as well as more humble members in countless African American communities,” grew into one of the largest African-American fraternal societies with more than 300,000 members nationwide “or more than 11% of all black men” by 1910.<sup>42</sup> In Warrenton, the GUOOF not only provided the type of mutual aid and civic engagement that the society was known for, but also provided space for the town’s school for African-American children during the period from the early 1870s through the 1910s. The school at 23 S. 3<sup>rd</sup> Street filled a critical gap in African-American education left by closure of the Freedmen’s Bureau School and prior to the establishment of Rosenwald Schools throughout Fauquier County. The GUOOF building also later served as the location of the

Walker Barber Shop, an important cultural and commercial institution for Warrenton's black community.

Another parallel black fraternal organization in Warrenton Historic District is the View Tree Lodge Masonic Hall, organized in 1912 and located at **11 S. 2<sup>nd</sup> Street (156-0019-0269)**. The View Tree Lodge Masonic Hall is a subordinate chapter of the Prince Hall Grand Masonic Lodge of Virginia. According to Skocpol and Oser, "The Prince Hall Masons were the first African American fraternal order," founded in 1775 in Cambridge, Massachusetts.<sup>43</sup> In the 1890s, the Prince Hall Masons were among the largest four fraternal groups of either race in South Carolina, Georgia, and Florida, and during the first three decades of the twentieth century the group reached record membership numbers.<sup>44</sup> Like other lodges and halls in Warrenton, the View Tree Lodge provided space for other uses for the African-American community, including a restaurant that provided Warrenton's black residents and visitors a place to dine during the Jim Crow era. The building located at **5 Diagonal Street (156-0019-0063)**, known as Moses Hall, which was the only frame building to survive the fire of 1909 on the western side of the district, was purchased by a black fraternal society and later was home to the local chapter of the Grand United Order of Moses. The Order of Moses was founded by Charlotte County resident James Murray Jeffress in 1904. As African Americans from rural areas of the south began to migrate to urban areas of the north, the Order of Moses spread to major cities throughout the United States. By 1951, the order had more than 5,000 members, thriving well into the post-World War II period.<sup>45</sup>

#### **Criterion A: Ethnic Heritage: African American**

The Warrenton Historic District is also locally significant under Criterion A in the area of **Ethnic Heritage: African American** for its association with the events of Reconstruction through the Civil Rights Movement in Warrenton. For more than a century after the close of the Civil War, nearly all aspects of daily life for most Americans, especially those living in the South remained racially segregated, including schools, social organizations, churches, neighborhoods, and businesses. At the close of the Civil War, Warrenton became the site of a field office for the Freedmen's Bureau, which also opened a school near 4<sup>th</sup> and Lee Streets in 1865. Records from this period indicate that Warrenton's Freedman's Bureau school experienced threats of violence, but that it also provided educational opportunities for an average of 50 day students and another 15 night students from 1866 to 1870. The building at **23 S. 3<sup>rd</sup> Street (156-0019-0280)** filled a

critical gap in African-American education left by closure of the Freedmen's Bureau School in 1870 through the establishment of Rosenwald Schools throughout Fauquier County in the 1910s. The district is also home to several prominent fraternal organizations that provided African Americans with outlets for social institution-making, civic engagement, mutual aid, and political autonomy including the **Grand United Order of Odd Fellows located at 23 S. 3<sup>rd</sup> Street (156-0019-0280)** beginning in the 1870s, the **View Tree Lodge Masonic Hall located at 11 S. 2<sup>nd</sup> Street (156-0019-0269)**, and the building at **23 S. 3<sup>rd</sup> Street (156-0019-0280)**. Similarly, **First Baptist Church located at 39 Alexandria Pike (156-0019-0004)** and **Mt. Zion Baptist Church located at 33 S. 3<sup>rd</sup> Street (156-0019-0283)** are representative of the late-nineteenth-century establishment of religious institutions that were central to the African-American community, often made significant contributions to local culture, and were instrumental in community and civic engagement.

Warrenton's historic commercial district was racially segregated until 1963, when local business owners came together at the **Fauquier National Bank Building located at 18 Court Street (156-0019-0020)** to force integration. The historic district, however, includes several buildings that are representative of the town's historic black businesses including: Madison's Barber Shop at **22 Main Street (156-0019-0205)**; Walker's Barber Shop at **23 S. 3<sup>rd</sup> Street (156-0019-0280)**; McLain's Tailor Shop at **205 Culpepper Street (now 51 Culpeper Street, 156-0019-0039)**, and **The Black and Gold, located at 31 S. 2<sup>nd</sup> Street (156-0019-0271)**.<sup>46</sup>

### **Criterion C: Architecture**

The Warrenton Historic District is also locally significant under Criterion C for **Architecture** for its noteworthy collection of high-style and vernacular architecture representative of the full evolution of the historic district ranging from the mid-to-late-eighteenth century through the mid-twentieth century. At least six examples of eighteenth-century architecture remain in the district, predominately along Horner and Winchester Streets. An outstanding example of mid-eighteenth-century architecture in the district is **Paradise located at 158 Winchester Street (156-0019-0320)**, which is believed to have been constructed in ca. 1765. Individually listed in the NRHP in 2013, Paradise evolved over time much like the rest of the district and features nineteenth century Italianate and Folk Victorian modifications to the original Federal style building. In addition to the early residences on Winchester Street, a number of fine, high-style dwellings line Culpepper Street ranging from early-nineteenth-century examples of the Federal style including the **Samuel Chilton House, ca. 1820, located at 97 Culpepper Street (156-0019-0047)** and the ca. 1840 house located at **140 Culpepper Street (156-0019-0053)** to the late nineteenth and early

twentieth century examples of Second Empire, Italianate, and Queen Anne residences. One of the finest and most unique examples of Second Empire style architecture in Warrenton is the Ullman House located at **157 Culpeper Street (156-0019-54)**, which features a Star of David in the mansard roof, representative of its association with the prominent Jewish family that constructed the home.

Warrenton Historic District also includes a number of architecturally significant institutional and religious buildings than span the district's period of significance. Located on the prominent junction of Waterloo Street, Courthouse Square, Alexandria Pike, and Main Street, the **Old Courthouse at 6 Court Street (156-0019-0351)** is a fine example of Classical Revival architecture constructed by prominent Warrenton architect and builder John R. Spilman. The ca. 1890 building was designed as a near replica of the early 1853 courthouse, which burned in the early 1880s.<sup>47</sup> The 1920s was also an important decade for institutional architecture primarily constructed in the Colonial Revival and/or Neo-Classical Revival styles near the town's historic core. Among the most striking examples are the ca. **1923 John Barton Payne Building/Warrenton Library located at 2 Court House Square (156-0019-0286)**; the ca. 1925 **Fauquier National Bank** building, designed by Stuart H. Edmonds, located at **18 Court Street (now the Warrenton Municipal Building, 156-0019-0020)**; and the **Fauquier County Clerk's Office located at 14 Main Street (156-0019-0199)**, designed by William H. Irwin in 1928.

This update to the Warrenton Historic District, which extends the period of significance to 1970, also makes contributing a number of Modern commercial buildings constructed during the 1940s, 1950s, and 1960s. The district also includes one International Style building constructed ca. 1970 located at **82 Main Street (156-0019-0232)**. The building's asymmetrical façade lacks ornamentation and the combination of concrete and brick, as well as the ribbon windows along the east elevation, are defining characteristics of the local expressions of International Style office buildings throughout Virginia. The district also includes a number of mid-twentieth century residences representative of the Colonial Revival style, and several examples of 1950s Ranch style houses. These mid-twentieth century resources represent the bookend of this architecturally diverse historic district, which includes a diverse range of architectural styles and forms.

Warrenton Historic District is also locally significant for its association with prominent Virginia and a few nationally-recognized architects listed below:

**Stuart H. Edmonds**, architect responsible for designing the ca. 1925 Fauquier National Bank building mentioned above, was active in Virginia from 1910 to 1931. A native of Winchester, Virginia, Edmonds designed a number of prominent buildings there including the Handley School in 1923 and the Winchester Memorial Hospital in 1926.<sup>48</sup>

**Emmett C. Dunn**, active from the 1880s through 1911, served as the city engineer of the city of Alexandria, Virginia during the 1880s. In addition to designing the ca. 1911 St. James Episcopal Church in Warrenton (73 Culpeper Street, 156-0019-0044), Dunn is also responsible for alterations to the Latrobe-designed St. Paul's Episcopal Church in Alexandria in 1905.<sup>49</sup>

**William H. Irwin Fleming** (1883-1961) was an Alexandria, Virginia-born architect who studied at George Washington University and Cornell University. Fleming, who opened his own practice in Washington, DC in 1917, was responsible for the designs of numerous public and private buildings in Northern Virginia, including the Fauquier County Clerk's Office (mentioned above) as well as The Oaks, a private residence located in Warrenton, though outside the historic district boundaries.<sup>50</sup> Fleming was also a member of the Allied Architects of Washington, DC, "a loose confederation of prominent local architects who banded together to pursue large public and semi-public commissions in the city."<sup>51</sup> The group was known to have worked collaboratively, and also used proceeds to "advance architecture...and to educate the public about good design."<sup>52</sup> The Allied Architects operated from 1925 to 1949, and designed numerous prominent buildings in Washington, DC.

**Samuel Sloan** (1815-1884) was a prominent Philadelphia-based architect most well-known for his contributions to the architecture of mental health. Sloan worked in collaboration with Dr. Thomas S. Kirkbride on what became known as the "Kirkbride System," "an architectural program that became the model for nineteenth century mental hospital design in the United

States.”<sup>53</sup> Among his most prominent works in this area include state mental health facilities in Pennsylvania, Alabama, North Carolina, and South Carolina. Sloan also designed numerous other public and private buildings, as well as churches. According to Wells and Dalton, Sloan was “one of the favored church architects of the Baptist and Presbyterian denominations.”<sup>54</sup> Sloan’s church design and expertise in the Italianate style are represented in the **Warrenton Baptist Church located at 123 Main Street (156-0019-239)**, constructed ca. 1860. During the mid-nineteenth century, Sloan also published a series of books on his designs and theories including *The Model Architect* (1852-1853), *City and Suburban Architecture* (1859), *Sloan’s Constructive Architecture* (1859), *Sloan’s Homestead Architecture* (1861), and *American Houses* (1861).

**John R. Spilman** (1857-1890) was one of Warrenton’s most prolific local builders/architects during the nineteenth century, and designed and/or constructed some of the town’s most prominent buildings. Among his works include the ca. 1876 **Warren Green Hotel located at 10-22 Hotel Street (156-0019-0355)** renovations and addition, ca. 1890 **Fauquier County Courthouse 6 Court Street (156-0019-0351/156-0002)**, and the ca. 1860 **Warrenton Baptist Church located at 123 Main Street (156-0019-239)**.<sup>55</sup>

**James Alphonso Wetmore** (1863-1940) originally started his career in the Department of the Treasury as a stenographer in 1885. Wetmore rose through the ranks to the office of Supervising Architect for the Department in Washington, DC. In this role, he designed numerous Federal buildings across the country from 1912 to 1932. Although Wetmore was not a trained architect or engineer, the *Architectural Forum* noted that “his name appears on the cornerstone of more buildings than any other man in history.”<sup>56</sup> In addition to Warrenton’s ca. 1919 **Post Office located at 53 Main Street (156-0019-0219)**, Wetmore is credited with at least 30 other post offices and/or post office alterations in Virginia from 1915 to 1932, primarily constructed in the Georgian Revival style.<sup>57</sup>


